- Establish good working relationships with Member companies.
- As required, attend EIC commercial and technical meetings and present where relevant.
- Present at relevant external energy related events that will raise the profile of the EIC
- Attend where appropriate and within the budget disciplines, relevant seminars, conferences and workshops.
- Provide resource and write Country and Insight Reports as directed.
- As directed support the Head of Consult to deliver future reports/strategies for members and non-members.
