## **International Delegation: Europe – CCUS The Porthos Project**

The Netherlands has clear climate objectives to reduce emissions of greenhouse gases by 49% by 2030 and by 95% by 2050, compared to 1990. One way to support and achieve the climate objectives is to capture CO<sub>2</sub> for use, or for storage underground through Carbon Capture Utilisation and Storage (CCUS). As the national coalition agreement and the national Climate Agreement underline the importance of CCUS for the energy transition, the Port of Rotterdam CO<sub>2</sub> transport hub and offshore storage (Porthos) project is a proposed joint venture partnership between three state-owned companies, including Energie Beheer Nederland (EBN), Gasunie, and the Port of Rotterdam Authority. This innovative CCUS project is being prepared near Europe's biggest port Rotterdam in South Holland, Netherlands, and is on schedule to store an annual amount of 2.5 million tonnes of CO<sub>2</sub> from the industry in empty gas fields beneath the North Sea as from 2024.
