Market Intelligence

Norway has a pivotal role in the Oil and Gas industry. According to the Norwegian Offshore Directorate, the country has increased its gas production between 2023 and 2024, from 233.3 million Sm³ to 240.6 million Sm³ produced respectively. The future seems to be bright, with a large number of projects targeting start-ups by 2027. Norway is an important player as an energy exporter, with 61% of its exports coming from this industry in 2024.

The country has played a stabilising role in the world's oil and gas supply, particularly in aiding assistance to Europe's energy crisis due to the absence of Russian supplies. According to EIC DataStream, Norway leads the Upstream sector in the number of projects up to 2030 and is placed 9th in terms of CAPEX. Further exploration activity is set to increase the country's opportunities, and major projects to mention include Balder, with Phase V and the recently sanctioned Phase VI starting in 2025 and 2026, respectively, and Johan Sverdrup Phase III and Yggdrasil starting in 2027. EIC DataStream targets 10 projects to reach FID by December 2025 in the country. Besides its relevance in the O&G sector, the country recognises the importance of renewable energy and energy transition, as a major market in the carbon capture sector.

The Northern Lights project is a major carbon capture and storage project with its first phase already capable of storing 1.5m tonnes of carbon dioxide every year with phase 2, reaching FID in March 2025, expected to store up to 5m tonnes of carbon dioxide every year. Three hydrogen projects for the maritime sector are to receive funding from the European Hydrogen Bank's second auction, HammerfestH2, Rjukan green hydrogen plant and Gen2 Energy's Mosjoen green hydrogen facility. As for the onshore and offshore wind industry, the country has 6.6GW and 4.1GW of planned capacity, respectively, reaffirming its interest in the energy transition.
