A hotspot of industry activity in the Oil & Gas sector, North America accounts for over US\$1 trillion in planned CAPEX across 700 projects in the upstream, midstream, and downstream sectors. The US Gulf of Mexico remains a strategic area for oil and gas players, hosting capital-intensive E&P projects such as Shell's Sparta and BP's new Paleogene production hub, as well as subsea tieback projects leveraging the region's extensive infrastructure. New discoveries in the Gulf further highlight the region's continued potential for growth and investments.

Meanwhile, US LNG export projects – which alone account for over US\$376bn of CAPEX in EICDataStream – remain under the spotlight, with LNG export approvals being fast-tracked to advance projects and reinforce the country's position as the world's leading LNG exporter.

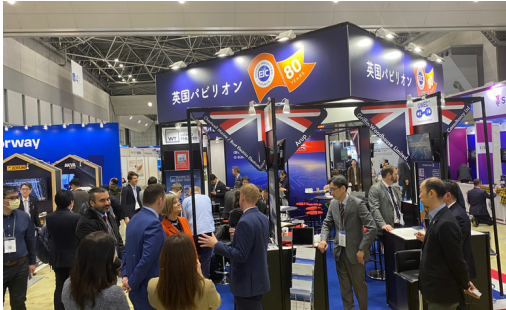
