The personal information we collect about you

When you access and browse the Website (including when you submit personal information to us through data entry fields on the Website), we may collect the following information from you:

- your name;
- your postal address;
- your phone, fax and e-mail details;
- your photograph;
- any dietary or access requirements you may have;

- details of an emergency contact person for you;
- information you provide to us by filling in forms on the Website;
- information about your employment, including your job title, responsibilities and activities carried out as part of your employment, and your employer's details; and
- feedback or quotes given by you in relation to any event, course, exhibition, function, or delegation arranged or facilitated by us.

How we may store and use your information

We (or third party data processors acting on our behalf) may collect, store and use your personal information listed above for the following purposes:

- to provide you with services that you request;
- to ensure that your requirements are met at any event, course, exhibition, function or delegation booked by you;

- in connection with our marketing, advertising, publicity, sales or other promotional materials;
- to include information in our directories, catalogues or delegate lists, where you have provided the information for that purpose;
- where you have given us your consent, to contact you (including by SMS and e-mail) with details of events, courses, exhibitions, functions or delegations which we think may interest you; and
- to disclose your personal information to the UK Government's Trade and Investment department and any subsequent or replacement department.

If a third party acquires all (or substantially all) of our business and/or assets, we may disclose your personal information to that third party in connection with the acquisition. We may also disclose your personal information where we are required to do so by applicable law, by a governmental body or by a law enforcement agency.

Finally, we may also collect anonymised details about visitors to the Website for the purposes of aggregate statistics or reporting purposes. However, no single individual will be identifiable from the anonymised details we collect for these purposes.

International transfers

We may transfer personal information that we collect from you to our group of companies (including to the following countries: Dubai, Malaysia, Brazil and the USA) in connection with the above purposes. Please be aware that countries which are outside the European Economic Area may not offer the same level of data protection as the United Kingdom, although our collection, storage and use of your personal data will continue to be governed by this privacy policy.

Cookies
