

- Attend a comprehensive 2-day programme on key topics with various high level sessions and lectures on three key topics



Germany is now set to embark upon a programme to decommission its 17 nuclear power plants, following the incident at the Fukushima Daiichi nuclear power plant in Japan, March 2011. The cost of decommissioning and waste disposal is estimated to be at least £50 billion. The scale of work ahead means that decommissioning is set to last into the second half of this century.
