#### **Breakdown of Participation Costs**

There are various cost elements involved, as detailed below:-

- (i) <u>Space</u> The cost of space is £475/sqm.
- (ii) <u>Facilities Charge including Upgraded Shell Scheme</u> In addition to walls, carpeting and company/EIC identification the stand package will also provide power, lighting, display aids and furniture.

Facilities include stand cleaning, an EIC Group Lounge facility, an EIC Group brochure, public relations, project management, organiser's costs, EIC Group branding, hanging banners and lounge consumables.

The above will be charged at a rate of £230/sqm. There are no facilities to book a free build stand within the group.

(iii) Management Fee

The EIC management fee for the work undertaken in organising, administering and supporting the EIC group at Offshore Europe 2017:

EIC Member - £725.00 (ex. VAT)

Non Member - £975.00 (ex. VAT)

#### (iv) Corner fee

There will be a £400.00 surcharge for each corner location. If you take more than one stand you will need to pay the corner fee per stand
